Opening Statement of Chairman Smith

Mr. Smith. The Subcommittee on Immigration and Claims will come to order.

I welcome you all here today for such an important hearing, and in just a minute I'll introduce our two witnesses who are here, but, first, I have an opening statement, as does the ranking member here as well.

In prior hearings we have explored the extent and the sources of illegal immigration and strategies for deterring illegal immigration. Today, we will look at the other side of the equation: the removal of illegal aliens, particularly those convicted of crimes, from the United States.

One reason for the crisis in illegal immigration is we have simply lost control of the deportation process. The numbers are staggering: there are more than 4 million illegal aliens in the United states, but the INS only institutes deportation proceedings each year against slightly more than 100,000 aliens. These efforts result in the removal of 40,000 aliens, and this is less than 1 percent of the overall illegal alien population.

There are many ways to illustrate how the deportation system is failing the American people. First, the deportation system is failing to protect U.S. citizens from criminal aliens. The INS estimates that there are 56,000 deportable aliens in State prisons and 21,000 in Federal institutions.

The percentage of deportable criminals in Federal prisons alone has risen 600 percent since 1983.
